1. PROMOTER

1.2. REPRESENTATIVE

Advice Group S.p.A., with registered office at no. 4 Via Riberi, 10124 Turin. VAT no. 09322540015.

2. TYPE

Prize draw

3. PERIOD OF VALIDITY

From 05/06/2023 to 01/10/2023 05/11/2023 (hereinafter, the 'Period of Validity').

There will be one draw for phase 1 of the prize draw by $\frac{02}{11} \frac{2023}{2023} \frac{07}{12} \frac{2023}{2023}$ and multiple draws for phase 2 of the prize draw by $\frac{2}{11} \frac{2023}{2023} \frac{07}{12} \frac{2023}{2023}$.

4. TERRITORY

This prize draw will be valid for the Period of Validity throughout Italian national territory and the Republic of San Marino, in the areas covered by the services of the Promoter or the Associate.

5. PURPOSE OF THE PRIZE DRAW

This initiative is aimed at promoting the services marketed by the Promoter and the Associate, promoting the use of Be Charge's free app (the 'App' or the 'Be Charge App'), and promoting the charging of electric vehicles at the charging points sited in Italian national territory and in the Republic of San Marino. 6. DEFINITION OF 'YOU'

'You' means all legal persons and natural persons over the age of 18, who:

- has downloaded the Be Charge App;

- has selected Italy when registering in the App as 'Charging Country', which indicates the country in which You wish to charge a vehicle. You may change this selection any time You deem it appropriate, by accessing the relevant section in the App.
- has applied to be a member of the Be Together initiative.

You will be identified by Your Be Charge identification code. This identification code is assigned automatically when registering in the App.

The following persons ARE EXCLUDED from entry:

- o anyone who downloads the Be Charge App on a device without registering ('Guest' users);
- anyone who entered a 'Charging Country' other than Italy when registering.

7. METHOD OF ENTRY

This prize draw is divided into two phases. To enter this prize draw, available exclusively during the Period of Validity, You must:

- download the Be Charge App;
- create a profile by registering at least Your name, surname, email address and telephone number;
- select Italy when registering in the App as 'Charging Country', which indicates the country in which You wish to charge a vehicle. The App has been developed to guarantee compatibility with the following platforms/languages:

- Apple iOS 13
- Google Android 6

Please note that an You may only participate via the App when there is an active internet connection; this is necessary to correctly receive all content. Once the App is installed, You must open it and navigate through the contents.

Please note that:

Apple Inc. ('Apple') does not sponsor the 'Promoter' and does not provide the service or sponsor any of the benefits offered as a prize;

Google Inc. ('Google') does not sponsor the 'Promoter' and does not provide the service or sponsor any of the benefits offered as a prize.

Also, the App is downloadable from digital platforms (Google Play for Android and App Store for Apple) whose respective owners are not involved in any way with the organisation and administration of the initiative. Their involvement is limited only to making available the abovementioned download systems. These digital platforms are only the technological method through which the App can be downloaded. Once downloaded, the digital platforms make the App available on Your device.

Prior to entering the prize draw, You are responsible for ensuring that Your device and internet connection are suitable for submitting a prize draw entry.
